#### Achievements

6 out of 10 (60%) [50% last year] of our full members automatically renewed their membership this year by fulfilling all of their member responsibilities. All of our members recorded *some* volunteer and open hours. As a group, we had the garden open for a total of **573 hours** [647 last year]. We collectively volunteered **375 man-hours** [542 last year]. We had 7 general meetings, all with a quorum, with one meeting in April canceled. Our garden has 15 of 36 member slots taken. 10 of them are voting members, 3 of them are new members, and 2 of them are working towards their key. All of this is despite the construction scaffolding obstructing the garden from April to August.

### New Members (Saplings)

To become a full member, you must be in good standing for a year from the date you started your membership. Then, full membership is put to a vote. New Members should aim for at least 25 open hours, 15 volunteer hours, and 4 meetings to match member requirements.
